

2022 Colorado Ski Country USA “Powder to the People” Sweepstakes—NO PURCHASE NECESSARY

OFFICIAL RULES

- 1. Introduction:** Colorado Ski Country USA (CSCUSA) is offering a sweepstakes. **NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**
- 2. Eligibility:** Entrant must be at least twenty-one (21) years of age and a legal resident of the 48 continental United States or the District of Columbia. Employees of CSCUSA, its member resorts and prize sponsors, their parents, subsidiaries, affiliated companies and agents and the immediate family (defined as parents, spouse, children, siblings, grandparents) of each of such employees and all of those with whom such employees are domiciled, are NOT eligible.
- 3. Timing:** Sweepstakes begin at 10:00:01 AM MST on Tuesday, March 1, 2022 and end at 4:59:59 PM MST on Thursday, March 31, 2022.
